

#### What is an accountant?

An accounting career is more than just crunching numbers on a spreadsheet. It's both challenging and rewarding where you get to make a real impact to the businesses you work with.

As an accountant you'll be building real relationships with your clients, working across a range of different sectors, and getting to know their business goals.

#### What doors can accountancy open?

1 in 5 CEOs of FTSE 100 firms started their career in accounting, making accounting a great foundation to your career and your long-term goals.

Accountancy qualifications are also recognised worldwide, opening up a broad range of opportunities.

Sometimes you'll get the opportunity to travel across the country to meet with clients, as well as attend networking and trade events.

#### **Career paths into accountancy**

The AAT (Association of Accounting Technicians) route provides you with everything you need to succeed in accountancy. It is a three year course and Robson Laidler will pay for your study with the AAT provider which usually involves visiting the provider one day per week. For the rest of the week you will be at

the office being paid a salary to work and gain experience as an accountant in an accountancy firm. AAT is an internationally recognised organisation and you end up with a degree-equivalent qualification.

In comparison, the University route is a three year degree. Most universities offer degrees in accountancy. You would then apply for jobs at an accountancy firm or in Industry.

# **Types Of Roles In Accountancy**

#### In Industry

When you are considering a career in accountancy, there are generally two different roles you may consider. Being an accountant 'In Industry' is working for a business such as Nissan or Northumbrian Water and helping to prepare their accounts.

#### In Practice

Being an accountant 'In Practice' is where you work in an accountancy firm, such as Robson Laidler, doing work for a wide range of clients from a local hairdresser to a multi-national corporation.

Both options provide a range of different opportunities for you to build and develop your skills and knowledge whilst learning the fundamentals of accountancy.



# **Your Journey As A Trainee**

- Junior: You'll be learning the ropes from preparing bank reconciliations and analysing client's manual records into cloud-based software to preparing small company accounts.
- Semi senior: You'll be proactively demonstrating your skills by preparing the
  majority of bookkeeping and annual work for small companies and charities
  autonomously.
- **Senior:** When you become a senior, you will be completing more technical accounts work including cash flow statements and consolidated group accounts. You will also be responsible in providing the juniors and semi-seniors with training and ensuring your knowledge is passed on effectively.
- **Assistant manager:** An assistant manager's role is to look after a number of the smaller clients which is a stepping stone towards management.
- Manager: In this role, you'll be responsible for a portfolio of clients and will stay in contact with these clients, recognising and responding to their business needs and provide quality advice on all accounting related issues.


